## **NEIGHBORHOOD CREDIT UNION & SIX FLAGS/HURRICANE HARBOR ANNOUNCE EMPLOYEE BANKING PARTNERSHIP**

DALLAS, Texas – Neighborhood Credit Union and Six Flags Over Texas/Hurricane Harbor today announced an agreement naming Neighborhood Credit Union as the exclusive banking partner for Six Flags Over Texas and Hurricane Harbor employees.
